We are still getting calls about the delay list process and procedure as well as handling of customers. After talking with both Carol Brown, and ALJ Yip-Kikugawa we feel that a short conference call would be appropriate for later this week. The purpose of the call is to ensure that we are all on the same page regarding the following issues:

- 2. Communication with customers who call your consumer rep dept. to ask to be put on the delay list
