I assume that PG&E will file its AET advice letter on Sept 1 addressing electric rates effective 1/1/12. I am preparing for that filing, and would like to request that PG&E provide some information about the upcoming AET AL.

Attached are 2 documents which are excerpts from last year's AET Resolution E-4379. The doc entitled "2010 AET Revenue Change Breakdown" (Attachment 1) is from pp. 3 through 6 of Res E-4379 and describes the change in revenue components that PG&E forecasted for 2011. Attachment 1 includes three tables showing 1. CPUC-authorized revenue changes, 2. FERC-authorized revenue changes, and 3. the sum of CPUC- and FERC-authorized revenue changes forecasted by PG&E (these tables are on pp. 5 and 6 of Res E-4379).

The attached doc entitled "2010 AET Cost Drivers" (Attachment 2) is from pp. 6 - 8 of Res E-4379 and describes the main reasons for the revenue changes shown in the 3 tables in Attachment 1.

I expect that the resolution addressing the upcoming AET advice letter will include similar text as that shown in Attachments 1 and 2.

Can PG&E please provide by **Monday Sept 12**:

1. Three tables in the same format as shown in Attachment 1, which show CPUC- and FERC-authorized revenue changes forecasted for 2012 for the different revenue components, as reflected in the upcoming AET AL (in an email dated 9/9/10 Megan sent this information for last year's AET to Energy Div), and

2. The main reasons for the revenue changes expected on 1/1/2012 provided in the tables in response to Q1, above.
