Yesterday CPSD received hardcopies of work being done to validate the safety of L132A and 147. We specifically shared the following:

**L132A (Main-line Pipeline):**

- 1) Updated PFL and MAOP Report
- 2) STPRs

**L147 (Main-line Pipeline):**

1) Two versions of PFL and MAOP Report ("as is" version based on the current pipeline system and another version that includes the 2011 work to be performed on the pipeline over the course of the next 2 weeks based on the engineering drawings sent for construction; we will provide an update of information based on hydrotest completion)

2) STPRs (2011 pressure test records to be submitted upon completion of the tests estimated to be by 10/14/11)

We expect to share information on the shorts for L132A and L147 this Friday, and for L101 on October 14. We will share the L147 STPRs as soon as they are available after October 14.
