The purpose of this meeting is to facilitate information exchange and continue the development of the action plan for the Research and Technology (R&T) Chapter of the CEESP[1]. The R&T Action Plan will be designed to help California achieve the Zero Net Energy (ZNE) and hot-dry climate HVAC technologies goals described in the California Long-term Energy Efficiency Strategic Plan (CEESP):

1. Research and Development to achieve incremental improvement in existing integrated demand side management (IDSM) technologies and breakthrough in advancing new

and/or emerging I DSM technologies

2. Commercialization including demonstration, deployment and consumer acceptance to advance the market adoption of integrated DSM technologies
