Neither Joe Malkin nor Lise Jordan, the lead attorney on the Records OII, nor any other PG&E person, was told in advance about the motion. Lise was on the phone with Bob Cagen 30 min before it was filed on another issue and he didn't mention it.

I want to clarify something. In terms of making docs public, all of the tens of thousands of docs provided in response to the OII, are public. Only employee names are redacted, or sensitive locational info. PGE gave thumb drives of the docs to media. The ECTS database that appears to be the focus of the motion was discussed with LD and my understanding is THEY AGREED at the outset to 583 treatment of that database and its 20k underlying docs. That is a living database with docs added all the time and there were too many employee names and locational references to redact. It would have taken too long and would have resulted in legal div not getting to see it for months.

If Legal Div believes they have a smoking gun they should tell PGE so we can address it. We have asked multiple times overnight and Bob implies they do, but they want us to find it. If true, they clearly don't care about protecting safety.
