On behalf of IBEW Local 569, we request that, pursuant to General Order 96-B Section 7.5.1, the Energy Division reopen the protest period for SDG&E Advice Letter 2247-E-A.

SDG&E's Supplement to the original advice letter changes both the price and the delivery date of SDG&E's power purchase agreement with its affiliate. However, the Supplement failed to include several important facts that are highly relevant to the value of the revised agreement. These facts include information regarding the likelihood that the new commercial operation date can be met and the relationship of the new price to current market data. While SDG&E claims that the changes to the PPA "provide significant ratepayer benefits," just the opposite is true.

Therefore, we request that the Energy Division reopen the protest period so that all of the facts can be presented to the Energy Division for your consideration.
