What is your local government contact plan to keep communities abreast of activity in the areas?

- On Oct 4th, PG&E launched a countywide electronic newsletter distributed to all elected and department heads. Monthly distribution going forward.
- Meet regularly (monthly in some cases weekly) with individual cities and County. We target City Managers, Department of Public Works Directors and their staff to provide updates and detailed information on major infrastructure upgrades, large construction projects, and city or county concerns. The staff meetings lead to updates provided at City Council or Board of Supervisor meetings on an as needed basis.
- Communicate to customers in that local area when work is being done via letters, town hall meetings, and/or phone calls.
- Presentations to San Mateo County CCAG board on topics such as Russell City interconnection project planned for November (originally scheduled for October and scheduled in November due to CPUC meeting with CCAG board). Other topics to be presented in the coming months include first responder training information, the Pipeline Safety Enhancement Plan, and Cornerstone
- We have committed and are beginning outreach to cities and County on outage communication, to ensure the elected officials and city/town staff is aware of outages. Improvements and development include:
 - A list of key local PG&E contacts and phone numbers that will be provided to San Mateo communities, perhaps as part of the newsletter
 - An expanded notification list for each city in the event of an outage.
