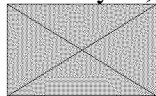

Dear ALJ Bushey,

In its October 10 filing of its plan for authorization to lift Commission-ordered pressure reductions, PG&E also asked you to issue a ruling setting a schedule for the Commission's consideration of the restoration of pressure on Lines 101, 132A and 147. Certain of the hydro testing and other field work associated with the request for Commission authorization will not be completed in time for the planned submission of supporting information this Friday, October 21. Accordingly, we request that you not issue a ruling setting a schedule for Lines 101, 132A and 147 at this time.

We plan to submit most of the supporting information within a week and will advise you and the other parties when we will be able to provide the balance of it. At that time, we will request that you issue a ruling establishing the schedule for the Commission's consideration of the pressure restoration.
