Enclosed is a copy of Pacific Gas and Electric Company's filing on September 30, 2011 in I.11-02-016:

FILED ON JUNE 20, 2011”**

This filing was originally submitted to the Docket Office on September 30 using the e-filing system and is now being resubmitted using the e-filing system on October 3, 2011. PG&E has resubmitted this filing to correct the following four inadvertent errors:

- (1) PG&E included unredacted documents on the public, redacted version of the DVD submitted to the Docket Office on September 30;
- (2) PG&E excluded three documents (Attachment Nos. P7-7137, P7-7140 and P7-7152 in the resubmitted Chapter 7 index) responsive to OII Directive No. 7 from the DVD submitted to the Docket Office on September 30, though the documents were listed in the Chapter 7 index;
- (3) related to the second error, PG&E included three documents that are not responsive to OII Directive No. 7 on the DVD submitted to the Docket Office on September 30, as the documents fall outside the time period covered by that Directive; and
- (4) PG&E included an incorrect date (February 10, 1997 instead of the correct January 9, 1989) in the Chapter 7 index for what is now Attachment No. P7-7152.

PG&E has corrected these errors in the Chapter 7 index and DVD in the resubmitted filing.
