Dear ALJ Bushey,

This is to follow up on my email of last Tuesday concerning the schedule for the Commission's consideration of the restoration of pressure on Lines 101, 132A and 147. We propose, and request that you incorporate in an ALJ's Ruling, the following schedule:

October 31

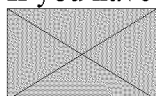
PG&E files and serves its Supporting Information (more than

	95% of the total information)
November 7	Confidential information available for review
November 15	PG&E files and serves its remaining Supporting Information (including safety certification by PG&E officer and CPSD concurrence)
November 17	Confidential information available for review
November 28	Evidentiary hearing
December 5	Proposed Decision
December 12	Comments on Proposed Decision (no reply comments)
December 15	Commission Decision

The Supporting Information we will file on October 31 will include all of the hydro test results and MAOP validation materials for all of Lines 101, 132A and 147, except for one pressure test for an off-take (also called a short) on Line 101, and the results of non-destructive examinations of three shorts on Line 101. Thus, starting on October 31, parties will have almost all PG&E's Supporting Information.

This approach, employing two submissions, allows parties four weeks to review the vast bulk of the support information prior to the evidentiary hearing. We hope the Commission and other parties will work with us to timely review this important pressure restoration.

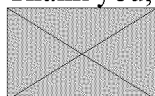
Dear ALJ Bushey,

In its October 10 filing of its plan for authorization to lift Commission-ordered pressure

reductions, PG&E also asked you to issue a ruling setting a schedule for the Commission's consideration of the restoration of pressure on Lines 101, 132A and 147. Certain of the hydro testing and other field work associated with the request for Commission authorization will not be completed in time for the planned submission of supporting information this Friday, October 21. Accordingly, we request that you not issue a ruling setting a schedule for Lines 101, 132A and 147 at this time.

We plan to submit most of the supporting information within a week and will advise you and the other parties when we will be able to provide the balance of it. At that time, we will request that you issue a ruling establishing the schedule for the Commission's consideration of the pressure restoration.
