Roland, Mel, Jeff --- I would like to add you to our team preparing this filing for distribution safety enhancements. We had a brief coordination call today --- the scope of this filing will include:

1. Plastic replacement program (Sara, Roland and the Aldyl-A team)
2. Distribution control system -- including distribution valves/SCADA and central gas control [Redac] Jeff and Mel)
3. GIS -- data capability to support DIMP (Sara and Roland)
4. Low Pressure system replacement [Redacted]
5. Possibly a couple other areas (to be determined)

I've put the names of the folks who are taking the initial lead on helping us scope each of these. Our timeline requires that we have this scoped out over the next 3 weeks, including forecasted costs and proposed timelines. There will be a case kickoff meeting Monday, and [Redacted] our case manager has already begun to assemble other resources -- including securing space in the December Bill Insert (quick thinking!). Chuck Marre will help us lift certain aspects of the transmission safety enhancement proposal into this filing.
