Subject: SoCalGas/SDG&E Joint Comments on Draft Resolution CSID-005

Attached is SoCalGas and SDG&E joint comments on Draft Resolution CSID-005 which would extend the Community Help and Assistance with Natural Gas and Electricity Services (CHANGES) pilot program to allow the Commission to evaluate 12 months of data.
