In each meeting, the representatives of CSDLAC described CSDLAC's generation facilities and its history of developing innovative renewable energy facilities. The

representatives also discussed the portfolio content categories of SB 2 (1X) and expressed the view that renewable generation facilities that meet the interconnection criteria of the first portfolio content category and that provide on-site power result in the creation of renewable energy credits that also meet the criteria of the first portfolio content category.
