The price paid to the FIT generator will be the executed contract price plus the project’s share of the transmission costs for the particular RAM contract. If the generator triggers transmission costs, then the generator should receive any payment for avoided transmission.

This section is missing the word “not” and, as corrected, should state as follows (additions are underlined):

The price paid to the FIT generator will be the executed RAM contract price plus the RAM project’s share of the transmission costs for the particular RAM contract. If the FIT generator triggers transmission costs, then the FIT generator should not receive any payment for avoided transmission.
