Sunil, Michelle, Julie,

As a follow-up to our conversation last week, we were able to resolve two potential supplemental items: one pressure test (Item 6 on the spreadsheet I shared with you last week - DREG 4207 in San Mateo) and one excavation (Item 2 – DREG 4198 in Menlo Park). This documentation will now be contained in the upcoming October 31 filing. The remaining three excavations and one nitrogen test (with spike test) on the L101 shorts will continue for the supplemental filing.

Also, you may have seen the schedule that we proposed to the ALJ today regarding the filing. As we agreed last week, it includes 3-4 business days for your review of the full package. You'll have received

more than 95% of the material by October 31 (much of it you've already received starting Sept 27 with our first rolling production). The documentation for the four remaining L101 shorts will be shared with you on Monday November 7 by 11 AM (or earlier if possible) and with your review expected by Thursday November 10 COB. We will then incorporate into the filing (making any necessary adjustments) and serve to all parties.

If you have any questions on the material you've received or will be receiving on Monday, please let me know.
