Subject: R111114 - UPRR - SACRAMENTO (Sacramento), Mainline Derailment, No Injuries

On November 13, 2011 at approximately 12:34 a.m., per Union Pacific Railroad (UPRR) and the California Emergency Management Agency report that UPRR train QRVWCB-12, lead locomotive UP 7625 had one railcar derail in the upright position, with no injuries reported near milepost 41.75 of the Fresno subdivision in the city of Sacramento, Sacramento County. According to the reports, UPRR train QRVWCB-12, for unknown reasons, derailed one box car in the upright position, which was carrying pipe, with no spills reported. A power pole was struck causing the lines to fall onto the tracks. There were no injuries, and no hazardous materials released due to this incident and no report as to how long the mainline was blocked. The Sacramento Police Department responded to the scene of the incident.
