Pursuant to Rule 8.4(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following ex parte communication. The communication occurred on Monday, November 7, 2011, at approximately 10:00 a.m. by phone. The communication was oral and no written material was used. [(Rule 8.4(a)(c))]

Erik Jacobson, Senior Director-Regulatory Relations, PG&E, initiated the communication with Sarah Thomas, Advisor to Commissioner Mark Ferron. [Rule 8.4(b)]

Mr. Jacobson pointed out the need for some minor corrections to Revision 3 of the Proposed Decision. He said Finding of Fact 43 should be deleted to be consistent with the deletions of this language from the Conclusions of Law and body of the Proposed Decision in Revision 3. He also stated that the "Market Price Referent" language added to Ordering Paragraph 5 and page 23 of the decision should be revised to read "Market Price Benchmark." [Rule 8.4(c)]
