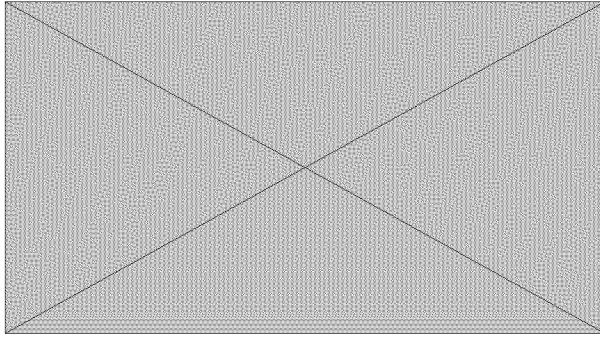

**TAKE ACTION**

*The CPUC typically allows public comment of 1-2 minutes, but you must arrive by 8:45am to sign up. If you arrive before the end of public comment (possibly 9:15- 9:30am) you can raise your hand to speak and they must give you 1 min. Take a minute and spread the word to friends and family- let's pack the chambers and remind this commission (and the utilities) who they're working for and who pays their salaries- the 99%!!!*

***2) CALL AND E-MAIL CPUC COMMISSIONERS, STATE LEGISLATORS AND THE GOVERNOR***

The commission as a whole has the power to vote down this extortionate opt out proposal, and they need to know how much we object to it. Comments should be submitted asap, but latest by December 12th. You should also contact your legislators and Gov. Brown at (916) 445-2841.
