ALJs Simon, DeAngelis, Mattson and Ebke:

Pursuant to Commission Rule 11.6, Pacific Gas and Electric Company (PG&E) respectfully requests a one-week extension for responses to the Joint Parties' Motion, so that responses would be due January 10, 2012. The Joint Parties' Motion requests workshops in January on pricing related issues and includes a detailed pricing proposal to be used as a "starting point" for workshop discussions. See Joint Parties' Motion at p. 7. Responses to the motion are currently due January 3, 2012. Many PG&E employees, and likely other parties' employees, have vacations scheduled this week and next week and thus will be unable to sufficiently review and prepare a response to the Joint Parties' Motion. Given the holiday schedule, a one-week extension is reasonable and will not significantly prejudice the Joint Parties.

Consistent with Rule 11.6, PG&E sent out an e-mail this morning to all of the parties indicating that PG&E intended to request an extension and making a "good-faith effort to ask such parties to agree to the extension." In response, Southern California Edison Company, San Diego Gas & Electric Company, and the Los Angeles Department of Water & Power indicated that they support PG&E's request for an extension to January 10, 2012. The Joint Parties indicated that they opposed a one-week extension, but would agree to an extension until January 5, 2012.
