Re: Pacific Gas and Electric Company Request for Extension of Time
to Comply with Decision 11-12-005 (R.11-03-006)

Dear Mr. Clanon:

Pursuant to Rule 16.6 of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) request an extension of time until December 31, 2011 to comply with Commission Decision (D.) 11-12-005 regarding PG&E's Tier 1 advice filing for revised tariffs to reflect the adopted California Department of Water Resources' Bond and Power Charges.

Ordering Paragraph No. 2 of D.11-12-005 states that "Within ten days of today's date, Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company shall file Tier 1 advice letters, as provided for in General Order 96-B, with revised tariffs that reflect the adopted Bond Charge. These new tariff shall be effective beginning January 1, 2012."

Likewise Ordering Paragraph No. 3 of D.11-12-005 states that "Within ten days of today's date, Pacific Gas and Electric Company and San Diego Gas & Electric Company shall file Tier 1 advice letters, as provided for in General Order 96-B, with revised tariffs that reflect the adopted Power Charges. These new tariff shall be effective beginning January 1, 2012."

The date of D.11-12-005 is December 1, 2011. Therefore to comply with Ordering Paragraph No. 2 and 3, PG&E must submit revised tariffs no later than December 12. (December 11 is a Sunday).

On or about December 31, 2011 PG&E will be submitting its Supplemental Filing – Annual Electric True-Up Filing to change PG&E Electric Rates on January 1, 2012. In this filing, PG&E proposes to incorporate changes to the electric rates that reflect the adopted Bond and

Power Charges. These rates will become effective on January 1, 2012. However this December 31 filing is beyond the required 10 days as specified in D.11-12-005.

PG&E respectfully requests that it be allowed an extension of time to December 31, 2011 to comply with D.11-12-005. With this time extension, PG&E can efficiently incorporate the adopted Bond and Power charges in its Supplemental Filing – Annual Electric True-Up filing.

If this request is granted, PG&E will promptly transmit the Executive Director's approval to all parties to Rulemaking 11-03-006.
