## TO ALL PARTIES OF RECORD ON THE ELECTRONIC SERVICE LIST FOR CPUC DOCKET NO. A.08-11-001:

This letter transmits the supplemental report of procurement activity by Pacific Gas and Electric Company ("PG&E") under the QF/CHP Settlement Agreement ("Settlement Agreement")<sup>1</sup>, pursuant to the Joint Semi-Annual Progress Report filed on December 1, 2011 ("Supplemental Report").

PG&E and the other investor-owned utilities ("IOUs") are required to detail their progress towards both MW Targets and Greenhouse Gas Emissions Reduction Targets, as defined by the Settlement Agreement, in semi-annual reports. The first report was due on December 1, 2011 - only four business days after the settlement effective date.

In their December 1<sup>st</sup> joint filing, the IOUs stated that, by December 23, 2011, they would serve a Supplemental Report of their procurement activity (MWs only) under the Settlement Agreement on the parties on the service list for CPUC Docket No. A.08-11-001

PG&E has prepared the attached Supplemental Report of MW that PG&E will count toward its MW Target and, by this letter, is serving its Supplemental Report as indicated in the December 1<sup>st</sup> filing.
