Sorry this took so long, but our team confirmed today that Commissioner Sandoval's efforts in reaching a settlement in the bonus depreciation proceeding will allow PG&E to invest nearly \$800 million throughout our service area and create about 4,800 new jobs.

In LA, I used the figures of nearly \$1 billion and 6, 000 jobs, but these amounts included the effects of bonus depreciation prior to the CPUC's decision.
