Southern California Gas Company (SoCalGas), San Diego Gas & Electric Company (SDG&E) and Southern California Generation Coalition (SCGC) appear to have reached a resolution of the issues raised in SCGC's Motion to Compel a Breakdown of SoCalGas and SDG&E Pipeline Safety Revenue Requirements Between Backbone Transmission and Local Transmission, filed in R.11-02-019 on December 19, 2011. SoCalGas and SDG&E have agreed to produce the breakdown sought by SCGC by January 17, 2012, and SCGC has agreed to extend the deadline for SoCalGas/SDG&E's response to the Motion to Compel until January 20, 2011.
