Subject: Reorganization of Gas and Electric Safety Functions in CPSD

Hello everyone- Over the last several years, CPSD has been working towards more specialization of its utility safety functions and with the recent increase in the number of gas utility engineers, we have decided it is time to officially restructure the Utility Safety and Reliability and the Electric Generation and Performance Branches into separate gas and electric functions. The result is that the old USRB and EGPB will become the Gas Safety and Reliability Branch and the Electric Safety and Reliability Branch. I have attached organization charts for the new branches.

The Electric Safety and Reliability Branch will be headed up by Program Manager Raffy Stepanian. The Electric Safety Section will be headed by Raymond Fugere and the Generator Safety and Reliability Section will be headed by Valerie Beck. Because Raffy currently has his hands full managing the San Bruno investigation, Valerie and Ray will take on some of the management duties for the new branch in the near term.

This week we expect to post a job bulletin to fill the Program Manager position for the Gas Safety and Reliability Branch. In the interim, Michael Roberston will serve as the Acting Program Manager. That leaves a void in Mike's Supervisor position. Sunil Shori will serve as Acting Program and Project Supervisor for the Gas Safety Section. Retired Annuitant Ken Koss will continue to assist with supervision for the new Risk Assessment and Enforcement Section.
