Advice Letter 261-E – NOTICE – Modifications to the Tariffs and Standard Contracts for the Purchase of Eligible Renewable Generation from Public Water and Wastermaster Facilities and Small Renewable Generators

This memo is to inform you that Regulatory Affairs has filed the above numbered advice letter with the California Public Utilities Commission ("Commission") on December 15, 2011.

PURPOSE

As directed in the December 1, 2011, Commission Resolution E-4442, BVES modifies its Schedule No. RET ("Renewable Energy Tariff") and Form No. 27, Renewable and Alternative Power-Public Water and Watermaster Agency Agreement, Appendix G ("Agreement") to include in both documents the adopted 2011 Market Price Referent (MPR) for the purchase of all energy produced by an eligible renewable generation facility.

Attached is the pending advice letter currently before the Energy Division.
