1. Does this apply only to pipes and wires or do we include generation and energy supply assets

2. The word "Security " appears in a few areas. Are you referring to I T or something else?

3. How or where do the IRP or NTSB recommendations fit in?

Also I would like to discuss how this effort will fit in with our GRC. Our current plan is to tender our NOI for the 2014 General Rate Case in July with the intent of having the GRC application filed in November, 2012. So the timing of this effort is another area to explore.

You may be aware that as a compliance order from our 2011 GRC, PGE was required to file authorized budgeted amounts for 2011 with an explanation of any differences with what was assumed in the settlement agreement in the GRC.
