I am awaiting final details, but wanted to pass on general logistics for you to think about as you decide whether you can make it next week.

The test location is remote. It has been described to me as "near Kettleman." There aren't buildings in the area, so we will need to connect somewhere that is easy to find before the drive out to the site.

You had mentioned flying, for example to Fresno, and renting a car. I just looked on line at flights and it seems impractical. Alaska Air flies into Fresno, via Seattle. United flies there via LA. In both cases it requires two flights and takes over 5 hours and costs at least \$500. And then you'd have to rent a car and drive another hour out to the site.

It's more likely you would elect to drive down, perhaps on Wednesday afternoon, and spend the night. I THINK Kettleman would be the closest place with motels, and that is about a 4 hour drive (according to Google Maps). Then someone from PG&E could meet you Thursday morning and get you to the site and you'd drive back Thursday afternoon.

Hydrotesting is a multi-stage process, as you may know, and the timing of testing activities varies according to conditions. Once the gas is removed from the pipe it is filled with water and then there is a waiting process for "settling" before the test is initiated. So the pressure test itself, while scheduled for Thursday, might not happen exactly when you would be there. But you would definitely see the process in action and have a chance to talk with the people who do the testing.

Just wanted to give you a general idea of what's involved in making the trip down to the site.
