While I was in Texas I was contacted by Commissioner Rolando Pablos' office to see if I could help arrange a couple meetings at the CPUC when Pablos is in SF next Tuesday. Gov. Rick Perry has appointed Rolando Pablos of Olmos Park and reappointed Ken Anderson Jr. of Dallas to the Public Utility Commission (PUC). The three-member PUC encourages competition and customer choice in Texas, and ensures electric and telephone operations, services and rates are fair and reasonable.

Pablos is an attorney in private practice and a senior advisor of SNR Denton. He is honorary consul to Spain, a member of the State Bar of Texas, chair of the San Antonio Free Trade Alliance, and a member and past board chair of the San Antonio Hispanic Chamber of Commerce. He is past chair of the Texas Racing Commission and City of San Antonio Small Business Advisory Committee, and a past board member of the Nueces River Authority and Greater San Antonio Chamber of Commerce. He is also a former adjunct professor at the University of Texas at San Antonio (UTSA), a past member of the UTSA College of Business

Dean's Advisory Council, and a graduate of Leadership San Antonio. Pablos received a bachelor's degree from St. Mary's University, a Master of Business Administration from the University of Texas at San Antonio, a master's degree in hospitality management from the University of Houston, and a law degree from St. Mary's University School of Law. He is appointed for a term to expire Sept. 1, 2013.
