All,

On December 2, 2011, I received the following motions:

- Motion of Southern California Edison Company to Withdraw Claims and of Settling Parties to Close Docket [A.08-11-001]

- Motion to Withdraw Joint Petition for Modification of D.07-12-052 of Southern California Edison Company, Pacific Gas & Electric Company, and San Diego Gas & Electric Company in R.06-02-013

- Joint Parties' Motion to Withdraw Pending Motions, Pleadings and Petition for Modification in Rulemaking 99-11-022 and to Close Docket

On December 6, 2011, I received Motion of Settling Parties to Withdraw Petitions for Modification and to Close Dockets R.04-04-003 and R.04-04-025. None of these motions have been opposed.

I am in the process of writing a proposed decision to address these motions. Since the motions are unopposed, I could waive the comment period if I were to grant the relief requested. However, in this instance, I am considering closing R.06-02-013, which is beyond the relief requested in the above motions. To allow the resolution of these motions in an expeditious manner, I am proposing to reduce the time for public review and comment to 5 business days for comments and 3 business days for reply comments. If any parties are opposed to reducing the comment period, please let me know by **Friday, January 20, 2012**.
