PACIFIC GAS AND ELECTRIC COMPANY'S FOURTH AMENDMENT TO RESPONSE FILED ON JUNE 20, 2011

On June 20, 2011, Pacific Gas and Electric Company (PG&E) responded to the directives in the Order Instituting Investigation (OII). Appendix A to the June 20th Response reproduced the five chapters contained in PG&E's Initial Response filed on April 18, 2011, and added new Chapters 1A, 2A, 2B, 3A, 6A-D, 7 and 8. In addition to the chapters in Appendix A, PG&E filed over 16,000 records. Those records form part of Appendices B and C to the Response. Appendices B and C also included 11 indices (some with sub-indices) listing the records according to the chapter to which they most closely correspond. On July 12, 2011, PG&E amended Appendices B and C to include additional records, add unique document identification numbers, take further steps to redact non-management PG&E employees, and correct document identification numbers in the index to Chapter 7. On September 13, 2011, PG&E filed a Second Amendment to the Response Filed on June 20, 2011, supplementing Appendices B and C with additional records responsive to OII directives. On September 30, 2011, PG&E filed a Third Amendment to the Response Filed on June 20, 2011, amending chapters in Appendix A and again supplementing Appendices B and C with additional records responsive to OII directives.

¹ Appendices B and C contained the same indices and redacted documents but differed in the data storage format used. Appendix B consisted of 27 DVDs filed with the Commission and Appendix C consisted of an external hard drive served on all parties.

This Fourth Amendment to the Response Filed on June 20, 2011 (Fourth Amendment) amends Chapter 2A of Appendix A to include references to additional documents responsive to OII Directive 2. Attachment A to this Fourth Amendment contains PG&E's amendments to Appendix A. The Fourth Amendment also amends Table 2A-2 in Chapter 2A to include additional and corrected information about the evolution of PG&E's gas transmission records practices. Much of the information added to Table 2A-2 derives from the additional documents identified in paragraph (a) below.

PG&E's Fourth Amendment also amends and supplements Appendices B and C as follows:

(a) Additional Documents Responsive to Directive No. 2

This amendment includes additional documents responsive to Directive No. 2, identified as Attachments P2-1459 through P2-1476. These attachments contain materials that discuss past PG&E recordkeeping practices. The attachments include documents discussing (1) the creation of PG&E's Vital Records program starting in World War II, its expansion in the late 1960s and developments during the 1970s; (2) an incident in 1973 of inadvertent destruction of records and a flood in 1982 in PG&E's Bayshore Records Center; (3) the need for additional records storage space and the ultimate expansion in the early 1980s of the Bayshore Records Center; (4) the creation in the early 80s of a computerized system to track records boxes in the Records Center; and (5) a chronology of the history of the Bayshore Records Center drafted in 1998 by Bayshore Records Center personnel for internal use. The attachments also include two revisions of PG&E's Decimal File Manual (1983 revision and 1990 revision), outlining a memoranda and correspondence filing system used internally to organize and retrieve documents between approximately 1948 and 1995, and some related documents.

(b) Additional Documents Responsive to Directive No. 7

This amendment includes additional documents responsive to Directive No. 7, identified as Attachments P7-7191 through P7-7196. These documents include a list of girth weld failures that PG&E believes were identified by Gas System Design Department personnel during the

development of the Gas Pipeline Replacement Program (P7-7191) in the early to mid 1980s, a list of hydrotest failures (many of which were previously provided in Chapter 7, as indicated in the "source" column) provided to the CPSD in a recent data response (P7-7192), and evaluations of long seam and girth weld defects provided to the CPSD in a recent data response (P7-7193 through P7-7196). The Chapter 7 index of attachments has been amended accordingly.

(c) Administrative Matters

This amendment corrects the Index of Attachments in Chapter 3/3A as to a document that was unintentionally omitted from production on June 20, 2011. The omitted document had been separately produced under another attachment number; the revised Index indicates that attachment number for reference. This amendment also corrects a technical issue that prevented production of attachment P3-27498. The corrected attachment has been substituted, and the Chapter 6C index of attachments and sub-index 17 have been amended to reflect the production date of the corrected attachment with this amendment.

Attachment B to this Fourth Amendment, consisting of a single DVD, updated indices to Chapters 2A, 3/3A, 6C, and 7, and updated sub-indices for Chapters 6C and 7, contains PG&E's amendments to Appendices B and C.
