Subject: R.11-02-019: Request for Extension of Time to Respond to SCGC Motion to Compel

ALJ Bushey,

Southern California Gas Company (SoCalGas), San Diego Gas & Electric Company (SDG&E) and Southern California Generation Coalition (SCGC) appear to have reached a resolution of the issues raised in SCGC's Motion to Compel a Breakdown of SoCalGas and SDG&E Pipeline Safety Revenue Requirements Between Backbone Transmission and Local Transmission, filed in R.11-02-019 on December 19, 2011. SoCalGas and SDG&E have agreed to produce the breakdown sought by SCGC by January 17, 2012, and SCGC has agreed to extend the deadline for SoCalGas/SDG&E's response to the Motion to Compel until January 20, 2011. Accordingly, pursuant to Rule 11.6 of the Commission's Rules of Practice and Procedure, we seek your authorization of this extension of time for SoCalGas/SDG&E's response to the Motion to Compel from December 29, 2011 to January 20, 2011.
