As a matter of clarification, TURN's document entitled:

that was served on the service lists for R.11-02-019 and A.11-11-002 today at approximately 2:57 p.m. was a re-service of the document previously served on the service list for R.11-02-019 on January 13, 2012, however slightly modified concerning the proceeding caption and proceeding number.

The previously served document on January 13, 2012 only included proceeding R.11-02-019 and was only served on that proceeding's service list. However, as a matter of correction, we have now included proceeding number A.11-11-002 along with R.11-02-019 on the document.
