## **Ford Motor, Kelly Services Earn Top Honors for Working With Women-Owned Businesses**

Two Michigan companies have made the list of America's Top Corporations for Women's Business Enterprises.

The Ford Motor Co. and Kelly Services are among 29 corporations recognized by the Women's Business Enterprise National Council, the Washington-based not-for-profit behind the list said today.

They were cited for "developing and driving innovative best practices across their organizations that result in productive business partnerships with women entrepreneurs and valuable products and services for their customers," according to the council.

This marks the first time the automaker, headquartered in Dearborn, has made the list. Troy-based Kelly Services has won twice.

Neither company could be reached for comment.
