I am sorry that other commitments prevented me from staying until the end of yesterday's workshop, when the date for redline comments apparently was established. On behalf of Sustainable Conservation, CEERT, and AgPower, we

cannot provide you with meaningful comments by Monday at noon. The tariff is lengthy. Parties received the tariffs one week prior to the workshop, and you are asking for comments basically 2 1/2 business days after the conclusion of the workshop. That does not allow parties who are so inclined to collaborate to provide you with one set of comments.
