# PACIFIC GAS AND ELECTRIC COMPANY'S UPDATE TO RESPONSE TO ORDER INSTITUTING INVESTIGATION

PG&E reported in its January 17, 2012 Response to the OII that it had determined that 48 segments out of the more than 26,000 segments reviewed were not operating commensurate with their present class location. Since filing that Response, PG&E has continued its review of the segments it classified as commensurate and has discovered that another 10 segments (1.5 miles),<sup>1/</sup> all of which were commensurate as of January 17<sup>th</sup>, were initially not commensurate with their class location.<sup>2/</sup> PG&E has replaced or hydro tested eight of these additional 10 segments; the other two continue to operate at a reduced pressure commensurate with their class location and longer-term action will be taken later this year, as shown in the following table:

<sup>1/</sup> Attachment A of PG&E's June 30<sup>th</sup> Report identified L300A, Mile Point 181.87 as one of the non-commensurate segments. Willbros has since split that 787 foot segment into two segments. This recent split is not reflected in this count because the total footage was included in both PG&E's June 30<sup>th</sup> Report and its January 17, 2012 Response.
