The Western Power Trading Forum¹ ("WPTF") offers the following brief reply comments in response to the opening comments filed by fourteen parties on January 31, 2012. Draft Resolution E-4471 ("DR") has pulled together such disparate interests as all the utilities, all the retail choice proponents, the major customer groups, consumer advocates, the unions and all the generator trade associations. Each individual intervenor has its own justification in asking for the rejection but the essential fact is that there is widespread sentiment that the DR should be rejected. WPTF therefore recommends that the DR be rejected and that the Commission move forward with a careful focus on resolving the real issues of import, which should be to craft resource adequacy requirements and forward procurement rules that identify future needs, including integration needs, and provide durable, transparent market mechanisms to meet those future needs.
