Re: PG&E Extension Filing for the 2011 Annual Reports

Dear Ms. Kim:

By your letter dated January 17, 2012, Pacific Gas and Electric Company requests an extension of time to file certain annual reports for 2011 required by General Orders 77-M, 104-A, and D.86-12-095.

First, PG&E requests an extension from April 2¹ until May 31, 2011 to file data required by G.O. 77-M on dues, donations, subscriptions, contributions and payments to attorneys. Your letter states that PG&E needs the extension to allow sufficient time to organize the recorded information and to enable PG&E to file a single rather than a bifurcated G.O. 77-M report. PG&E proposes to file this data at the same time it files the G.O. 77-M report on compensation on May 31, 2012 as required by D. 06-12-029. PG&E's request for extension to file the G.O. 77-M report on dues, donations, subscriptions, contributions and payments to attorneys on May 31, 2012 is granted.

Second, PG&E requests an extension of time from April 2, 2012 to April 30, 2012 to file the G.O. 104-A Annual Report and the G.O.104-A Standard Pacific Gas Line, Inc. Annual Report. Your letter states that the financial information required in these reports is similar to information included in the annual reports to the Federal Energy regulatory Commission (FERC) which are due on April 18th of each year. Your letter notes that additional time is needed to ensure consistency with annual reports to the FERC. PG&E is hereby granted the extension as requested to file the G.O 104-A Annual report and the G.O.104-A Standard Pacific Gas Line, Inc. Annual report.


¹ D.06-12-029 requires that PG&E file the G.O. 77-M data on dues, donations, subscriptions, contributions, and payments to attorneys by March 31 of each year. Since March 31 falls on a Saturday this year, the due date for 2011 without the requested extension is Monday April 2, 2012.

Finally, PG&E requests an extension of time to file the Gas Pipeline Replacement Program (GPRP) annual report required by D. 86-12-095 from April 2, 2012 to April 30, 2012. Your letter states that additional time is needed to analyze data for this report.

PG&E is hereby granted the extension as requested to file the GPRP annual report on April 30, 2012. PG&E shall serve a copy of this letter on the service lists for its 2011 general rate case A.09-12-020, R.05-10-030 and I.10-07-027 within 2 business days of receipt of this letter and service may be done by email.
