**Re: PG&E's Comments on Draft Resolution E-4455**

Dear Mr. Gatchalian and Ms. Salinas:

Pacific Gas and Electric Company ("PG&E") submits the following comments on Draft Resolution E-4455 ("Draft Resolution"), which was issued on February 2, 2012. The Draft Resolution approves without modification amendments to five Qualifying Facility ("QF") Standard Offer power purchase agreements (collectively, the "Amendments") that PG&E has executed with Covanta Mendota, L.P. ("Mendota"), Rio Bravo Fresno ("Fresno"), Rio Bravo Rocklin ("Rocklin"), Wheelabrator Shasta Energy Company, Inc. ("Shasta"), and Pacific-Ultrapower Chinese Station ("Chinese Station"), collectively (the Sellers"). While PG&E supports the Draft Resolution's approval of the Amendments without modification, it requests that the Commission correct factual errors contained in the Draft Resolution regarding the term of the Amendments.

The existing PPAs are 30-year Interim Standard Offer 4 ("ISO 4") contracts that expire on various dates. As PG&E explained in Advice Letter 3921-E, the Amendments provide the Sellers with a higher price for delivered energy in exchange for stricter performance obligations and other beneficial terms and conditions. The Amendments will take effect on September 1, 2011. The term of the Mendota amendment is approximately three years and four months, and the term of the Fresno, Rocklin, Shasta, and Chinese Station amendments is four years and eleven months. The amendment term, amendment expiration date, and PPA expiration date for each facility is outlined below:

PG&E provided the above-described information in Advice Letter 3921-E and its Confidential Appendices<sup>1</sup>.

The Draft Resolution incorrectly describes the term of each of the Amendments and uses this information in its analysis. Specifically, the Draft Resolution incorrectly refers to an initial three-year term with an option to extend for one year and another option to extend for an additional 11 months.<sup>2</sup> The Amendments do not, however, contain any options to extend, but are rather for one fixed term as described in the table above.

PG&E requests that the Commission modify the Draft Resolution to include the correct Amendment terms and continue to approve the Amendments without modification. PG&E's proposed changes to the Findings and Conclusions and the Ordering Paragraphs are provided in the attached Appendix A.

## Appendix A to PG&E's Comments on Draft Resolution E-4455

### Proposed Changes to Findings and Ordering Paragraphs

Consistent with its comments on the Draft Resolution, PG&E recommends that the Commission make the following changes to the Findings and Conclusions and the Ordering Paragraphs in the Draft Resolution:

#### Findings and Conclusions

16. Deliveries from the Five Facilities will help fulfill PG&E's near term RPS obligations, ~~however beyond the initial term, the need for the energy from these projects is less certain given the contracting PG&E has done to date and potential future contracting activities.~~

#### Ordering Paragraphs

1. Pacific Gas and Electric Company's Advice Letter 3921-E, as amended by Advice Letter 3921-E-A, requesting Commission approval of ~~a three-year~~ amendments to five existing Qualifying Facility (QF) contracts ~~and the option to extend (where applicable) the proposed amendment by 1 year, and subsequently (where applicable), an additional 11 months,~~ with Covanta Mendota, L.P., Rio Bravo Fresno, Rio Bravo Rocklin, Wheelabrator Shasta Energy Company, Inc., and Pacific-Ultrapower Chinese Station is approved without modifications.
