• Negotiation Status:

○ In the definitions for Executed projects (excluding FITs), for the N/A drop down option add "Select this".

• CPUC Approval Status:

○ Add a drop down "N/A". For the definition for N/A include "If N/A is chosen please explain in General Project Information Notes".

• Contract Capacity:

○ In the definitions for projects under negotiation and executed projects, please delete the PG&E specific examples (Powerex, Klondike, Shells, PacifiCorp).
