All,

This afternoon I received a letter from CPSD, in which it requested an additional week to file its testimony. CPSD's letter states that PG&E does not oppose the extension request. I am granting CPSD's request. The testimony is now due March 12, 2012. Additionally, I will be scheduling a prehearing conference for Tuesday, March 20 at 9:00 a.m. to discuss the impact of this extension on the filing of intervenor testimony and PG&E's rebuttal testimony. The PHC will not last more than 45 minutes, so that it does not conflict with ALJ Bushey's evidentiary hearings in R.11-02-019.
