**MOTION FOR PARTY STATUS OF

Camco International Group, Inc. (“Camco”) respectfully moves for party status in this proceeding in accordance with Section 1.4 of the California Public Utilities Commission’s Rules of Practice and Procedure.

**I. DESCRIPTION OF CAMCO.**

Camco is the North American division of Camco International Ltd., a global developer of carbon offset projects and solutions to reduce greenhouse gas emissions with operations in the United States, the UK, China, Africa, Russia and Southeast Asia. We have been providing our clients with project development expertise, technical delivery capabilities and policy advice for over 20 years and generating offsets in North America for over 5 years. Based in Denver, Colorado, and incorporated in Delaware, Camco holds the largest number of Livestock Gas Capture/Combustion projects registered on the Climate Action Reserve and is evaluating, investing in and developing Livestock Gas Capture / Combustion projects in California and other Western States. Camco seeks to offer offsets from our emission reduction projects to regulated

utilities covered under California's cap-and-trade regulation and subject to Commission jurisdiction.
