Dear ALJ DeAngelis and Parties:

The IOUs have reviewed and discussed the request from the Clean Coalition and we agree with the Clean Coalition that it would not be the best use of everyone's resources to have further comment on the proposed PPA until it conforms with the Commission's adopted policy provisions for the Feed-in-Tariff. Because there is only a Proposed Decision at this time, it would be premature and speculative to try to incorporate those policy provisions now. The IOUs therefore propose to suspend the currently scheduled workshop and follow on comments until the Final Decision is issued. Once there is a Final Decision, we will produce and circulate a new version of the PPA within an appropriate timeframe. We would then host a workshop to review the conforming draft and, following the workshop, receive comments and then prepare a final PPA for filing with the Commission.

Accordingly, the IOUs request that the workshop scheduled for April 3rd and the comments following that workshop be suspended until the Commission issues a Final Decision on the program parameters and ALJ DeAngelis is able to issue a ruling with a revised schedule. This response is being submitted on behalf of SDG&E, Southern California Edison and PG&E.

The Clean Coalition would like to request that the IOUs prepare a revised Standard Form Contract (PPA) that takes in to account the policy decisions proposed in the Proposed Decision on implementation of SB 380, SB 32, and SB 2 (1X) released on March 20.

In this way, parties will not waste time providing comments on PPA provisions that are unlikely to be retained once the final decision is approved. The Proposed Decision contains several provisions directly implicating the PPA. For example, two provisions that are controversial in the PPA:

1) Resource Adequacy. The Proposed rule would require at a minimum replacing Section 4.4 of the proposed PPA

2) Transmission Termination right: If projects fit the proposed requirements for "strategically located", section 14.9 of the PPA is no longer relevant

The Clean Coalition requests that the IOUs prepare this revised PPA before further scheduled conversations so that those conversations will be effective and efficient.
