The pleading sets forth the ISO proposed revisions to the final decision, but does not show how the revisions differ from the current text.

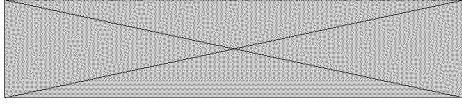
