**We'll go ahead and select Valley Industrial X-Ray & Inspection to perform the evaluation. For this particular work, please request this vendor to provide an analyst with Level 3 certification. As far as the 6-foot by 6-foot excavation, it will be adequate as long as it covers the same area covered by the H-Forms for the same excavation at this location as in the August 2011 hydro-test. Otherwise, we may need to extend the excavation beyond the planned 6 foot by 6-foot area.**

Hi Sunil:

Below is a list of X-Ray inspectors that we currently have under contract. JAN X-Ray is the parent company of WIX and we don't want to use them on the examination of T-47A. Please choose one of these companies as soon as possible and we'll use them for the T-47A examination. I will try to have a firm schedule for you on Monday, but it looks like we may have the holes ready for examination by next Friday. We have the land rights secured and a digging crew has been scheduled. It will take 2 to 3 days to have the pipe excavated. Our plan is to dig 6 foot by 6 foot holes over each weld (four holes total) and drop in a shoring cage to protect the examiners in the hole. This will expose about two feet of vintage pipe in each hole. Let me know if this works for you.
