Thank you for sending us the tariff in Word format. I am sorry that other commitments prevented me from staying until the end of yesterday's workshop, when the date for redline comments apparently was established. On behalf of Sustainable Conservation, CEERT, and AgPower, we cannot provide you with meaningful comments by Monday at noon. The tariff is lengthy. Parties received the tariffs one week prior to the workshop, and you are asking for comments basically 2 1/2 business days after the conclusion of the workshop. That does not allow parties who are so inclined

to collaborate to provide you with one set of comments. This seems particularly unfair given the utilities were provided with an additional two months to prepare these tariffs, beyond the date originally set by ALJ DeAngelis.

We understand that you are trying to keep this process moving. We respectfully submit that you will receive more thoughtful comments if parties have at least another week, until March 5. Please advise.
