The Clean Coalition would like to request that the IOUs prepare a revised Standard Form Contract (PPA) that takes in to account the policy decisions proposed in the Proposed Decision on implementation of SB 380, SB 32, and SB 2 (1X) released on March 20.

In this way, parties will not waste time providing comments on PPA provisions that are unlikely to be retained once the final decision is approved. The Proposed Decision contains several provisions directly implicating the PPA. For example, two provisions that are controversial in the PPA:

- 1) Resource Adequacy. The Proposed rule would require at a minimum replacing Section 4.4 of the proposed PPA
- 2) Transmission Termination right: If projects fit the proposed requirements for "strategically

located", section 14.9 of the PPA is no longer relevant

The Clean Coalition requests that the IOUs prepare this revised PPA before further scheduled conversations so that those conversations will be effective and efficient.
