ADVICE LETTER 2106-G (U 902-G)

PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

SUBJECT: ESTABLISHMENT OF THE PIPELINE SAFETY AND RELIABILITY MEMORANDUM ACCOUNT (PSRMA) PURSUANT TO DECISION 12-04-021

San Diego Gas & Electric Company (SDG&E) hereby submits for filing the following revisions to its gas tariffs as shown on the attachment.

PURPOSE

The purpose of this advice filing is to request approval from the California Public Utilities Commission (Commission) to revise SDG&E's Gas Preliminary Statements, Section V (Memorandum Accounts), and establish a Pipeline Safety and Reliability Memorandum Account pursuant to Ordering Paragraph (OP) 3 of Decision (D.) 12-04-021.

BACKGROUND

On April 19, 2012, in D.12-04-021, the Commission, among other things, adopted the transfer of the reasonableness and ratemaking review of the Natural Gas Pipeline Safety Enhancement Plan (PSEP) proposed by SDG&E and Southern California Gas Company from Rulemaking (R.) 11-02-019 to their pending Triennial Cost Allocation Proceeding (TCAP) Application (A.) 11-11-002, and authorizes the establishment of a memorandum account for both companies as described below.

PSRMA

Pursuant to OP 3 of D.12-04-021, SDG&E is establishing the PSRMA to record for later Commission ratemaking consideration the total, fully loaded and escalated costs of implementing its PSEP and costs associated with the review of records and implementation of interim safety measures, as described in Attachment A and B, respectively, filed in its January 13, 2012 comments supporting the transfer of the PSEP to the TCAP and providing further detail on its proposed memorandum account. Specifically, the PSRMA will record incremental costs incurred during the first 12 months of implementing the PSEP, the costs associated with the review of records in compliance with Commission Resolution L-410, and the implementation of interim safety measures. The disposition of the PSRMA balance will be addressed in SDG&E's 2013 TCAP. SDG&E anticipates implementing it PSEP beginning June 1, 2012.

EFFECTIVE DATE

SDG&E believes this filing is subject to Energy Division disposition and should be classified as Tier 2 (effective after staff approval) pursuant to GO 96-B. This filing is consistent with D.12-04-021 and therefore SDG&E respectfully requests that this filing be approved and effective on May 20, 2012, which is 30 days after the date filed.

PROTEST

Anyone may protest this Advice Letter to the California Public Utilities Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received no later than May 10, 2012, which is 20 days of the date this Advice Letter was filed with the Commission. There is no restriction on who may file a protest. The address for mailing or delivering a protest to the Commission is:

V. MEMORANDUM ACCOUNTS PIPELINE SAFETY AND RELIABILITY MEMORANDUM ACCOUNT (PSRMA)

1. Purpose

The purpose of the PSRMA is to record the incremental costs associated with compliance with the Commission's directives in Rulemaking 11-02-019. In Decision (D.) 12-04-021, the Commission directs SDG&E to file this advice letter to create a memorandum account to record the escalated direct and incremental overhead costs of implementing its proposed Pipeline Safety Enhancement Plan (PSEP), as well as the costs associated with the review of records and interim safety measures. Should cost estimates for implementing the PSEP and reviewing records increase by more than 10%, SDG&E will file a Tier 1 advice letter notifying the Commission of such increased costs.

2. Applicability

This account shall apply to all gas customers, except those specifically excluded by the Commission.

3. Rates

See Disposition Section.

4. Accounting Procedures

The Utility shall maintain the PSRMA by recording entries at the end of each month as follows, net of FF&U where applicable:

- a. A debit entry equal to the actual incremental costs (i.e., O&M and capital-related costs such as depreciation, income taxes and return) associated with the PSEP costs incurred during the implementation of its PSEP;
- b. A debit entry equal to the incremental costs associated with the review of records performed in compliance with Commission Resolution L-410 and implementation of interim safety measures, pursuant to D.12-04-021;
- c. An entry equal to the amortization of the PSRMA balance as authorized by the Commission; and
- d. An entry equal to the interest on the average of the balance at the beginning of the month and the balance after the entries above, at a rate equal to one-twelfth of the interest rate on three-month Commercial Paper for the previous month, as reported in the Federal Reserve Statistical Release, H.15, or its successor publication.

5. Disposition

The disposition of this account will be addressed in a Commission decision in SDG&E's 2013 Triennial Cost Allocation Proceeding (Application 11-11-002) or other future Commission decisions.
