President Peevey has requested that the Policy and Planning Division of the CPUC look into the issue of corporate sustainability within the three investor owned utilities. We will approach this task in a three-phase process. First, throughout the month of May PPD staff and Carol Brown, president Peevey's chief of staff, will meet with representatives of each of the utilities to discuss their programs and achievements to get a better understanding of what has been done by each IOU to date. We will then hold an en banc at the Commission on August 21, 2012, to share that information with our Commissioners, commission staff, ratepayers, stakeholders, and other interested parties. The third part of this process will be an invitation only industry roundtable with President Peevey to discuss challenges and opportunities moving forward. This roundtable will be held on August 22, 2012.

At your earliest convenience, I would like to touch base over the phone to provide you with more details on this process and to discuss setting up the initial meeting here at the CPUC. Please let me know when would be a good time to set up a call.
