Summary: Scoping Ruling Assigned Commissioner's Scoping Memo and Procedural Ruling. The scope and schedule for this proceeding as set forth in the body of the ruling are adopted. This proceeding is categorized as ratesetting. No hearings are needed to resolve energy efficiency incentive issues for the 2010-2012 cycle. A determination of the need for hearings on 2013-2014 incentive issues will be determined later pending the results of comments, workshops, and further review thereof. The Presiding Officer for this proceeding is ALJ Thomas Pulsifer. The Commission's ex parte communication and reporting rules set forth in Rule 8.2 and 8.3 (c) shall apply in this proceeding. In accordance with Rule 17.1(a)(1) and Public Utilities Code Section 1804(a)(1), the notice of intent to claim intervenor compensation was to be filed April 20, 2012..
