Laura,

I can provide you with copies of the records, but it may take a few days. For one thing, my staff waits until we receive a signed and conformed copy of resolutions authorizing disclosure before we send the documents. This usually takes a day or two. Second, my staff will need to copy the records, which fill several binders, make the necessary redactions, scan the documents so that we can make them available electronically, copy them to a CD for the requester, and now, for you as well.

I think PG&E already has pretty much all of these documents, since most of them were either provided to the Commission by PG&E, or sent to PG&E in the form of CPSD correspondence regarding the leak survey audits, etc., so I suppose one other process might be for you to see what PG&E has in its own files. Nonetheless, I know you would still be interested in seeing the batch of records we provide the requester, so I will have my staff make an extra copy for you.

I hope this is helpful.
